That the party of the first part will be solely responsible if any accident takes place or any injury is caused to any of the students while taking education in the hospital.

That the party of the first part or its students will also not ask any fees or honorarium from the party of second part.

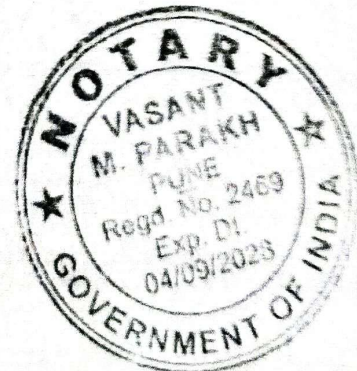

It is also agreed by the party of the first part that in case of any damage is occurred to the property of the party of the second part from the students while taking education, then it will be fully recouped or compensated by the party of the first part. In this regard the decision regarding the quantum of damages decided by the party of the second part will be final and conclusive. 2. HOURS OF PLACEMENT IN THE CLINICAL AREAS

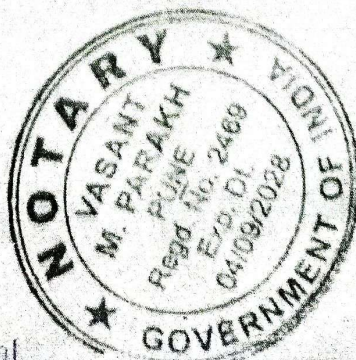
The nursing students will be posted as per curriculum prescribed by Indian Nursing council, MUHS Nashik except during holidays, vacation and examination and for institutional activities.
